



**Eddy County Fair July 20-25, 2015 Food Concession Contract**

This contract shall be an agreement between the Eddy County Fair Association, Inc. and \_\_\_\_\_, known as food vendor for the Eddy County Fair according to the terms as follows:

1. The Eddy County Fair will open to the public at 4pm on Monday and run through Saturday @5pm.
2. Food concession hours shall be as follows:  
 Monday from 4pm to 9 pm  
 Tuesday & Wednesday 10am to 9pm  
 Thursday & Friday 10am to 10pm  
 Saturday 9am to 5pm (or later it is up to you)
3. The rental fee includes ONE-220 plug per space with an additional \$100.00 per each additional 220 plug used (this includes supply trailers as well).
4. Deadline for all food concession reservations shall be June 30.
5. All food vendors are to obtain proper health inspection documents as well as any necessary permits to operate a food concession. These arrangements should be made in advance and shall between the Food Vendor and New Mexico State Health Inspector and shall be the responsibility of the Food Vendor. The Eddy County Fair Association, Inc. is under no obligation to either of these parties.
6. A copy of such documents shall be present and visible in concession booth at all times. Failure to have made such arrangements by 3:00pm on Monday will result in immediate termination of contract. The food vendor will then be instructed to leave the Eddy County Fairgrounds with rental fees and or deposits forfeited.
7. All food concessions shall be familiar with, demonstrate and follow all rules, regulations and guidelines as set forth by the New Mexico State Environment Department for a safe and sanitary food service environment.
8. The Eddy County Fairgrounds will be open for food concession move in and set up from Friday at 8am through 1:00pm on Monday.
9. The food vendor shall be responsible for any and all damages to the concession area and shall be billed for such damages. This includes grease overspill, trash and or pavement damage. The Eddy County Fair Association, Inc reserves the right to hold random food concession inspections.

The Eddy County Fair Association, Inc. agrees to provide the following:

- a. To provide as much advertising and publicity via: news papers, radio, and television as is practical.
- b. To open Fair Grounds and/or buildings to provide ample time for set up.
